## ORDER:

Government vide G. O. reference 1<sup>st</sup> read above, have issued orders, approving fiscal benefits covering the categories of **(a)** Micro, Small & Medium Enterprises **(b)** Large Industries **(c)** Scheduled Caste & Scheduled Tribe Entrepreneurs **(d)** Backward Class Entrepreneurs **(e)** Women Entrepreneurs and **(f)** Mega Projects Under the new "Industrial Development Policy (IDP) 2015-2020".

- 2. Government after careful examination hereby issue the following amendments/additions to Industrial Development Policy 2015-20 issued vide G.O. Ms. No.36, Ind. (IP&INF) Department, dt:29.04.2015:
  - (i) para 5.73. (b) of the order shall be read as follows:

"Land shall be allotted on 99 years lease or outright sale as per land allotment rules of APIIC, as per request of proponent".

- (ii) after Para 5.7.3.(b) of Government order Para 5.7.3.(c) is added as follows:
  - "APIIC shall institutionalise a third party system for monitoring the utilisation of allotted land and the progress of project implementation".
- (iii) point 3(c) Land allotment in Annexure-I to G.O. Ms. No. 36, Ind. & Com. (IP & INF) Department, dt:29.04.2015 shall be read as follows:

"Land shall be allotted on 99 years lease or outright sale as per land allotment rules of APIIC, as per request of proponent".

(iv) after point 3(c) Land allotment in Annexure-I to G.O. Ms. No. 36, Ind. & Com. ( IP & INF) Department, dt:29.04.2015 order, Point 3 (d) is added as follows:

"APIIC shall institutionalise a third party system for monitoring the utilisation of allotted land and the progress of project implementation".

3. The Vice Chairman and Managing Director, Andhra Pradesh Industrial Infrastructure Corporation shall take necessary accordingly.
