- c. - 5. Sealed quotations will be opened before the empanelled bidders or their authorized representatives. Whoever quotes less price (lowest price) to the LIDCAP in terms of value on each product will be given an opportunity to supply the footwear and leather goods and Supply Order will be placed on the successful empanelled manufacturer or supplier accordingly.
